










# **Our Business: Forestry**








- Hasnur Group manages approximately 200.000 ha natural forest in Central Kalimantan,
- We currently produce timber logs, and veneer and wood chips in the near future,
- Hasnur Group forestry operation has met the standards of verification on the legality of timbers, and obtained the Timber Legality Verification System (SVLK\*\*) certificate no. 09/A-SERT-VLK/Kpts/I/2013.

# **Our Business: Mining**






- Hasnur Group has two active coal mining concessions in South Kalimantan,
- We produce 20,7 million MT thermal coal in the last three years. Last year we produced 10 million MT,
- Hasnur Group has integrated coal mining and logistic services from mining, transportation, special port, and coal transhipment,
- Hasnur International Shipping is the company that manages around 40 sets tug and barge, and owns 11 sets,

- Hasnur Group currently has 18,000ha planted palm oil plantation in South Kalimantan, with additional landbank around 40,000ha,
- We currently produce CPO, and its derivative in the near future,
- Hasnur Group has received certificate in ISPO (Indonesia Sustainable Palm Oil) in 2016.
