Two categories of Membership

1. Ordinary Membership – Have Voting Rights:

Greek and foreign Companies and Associations based and doing business in Greece.

- Corporate Membership** – Corporations pay an annual subscription fee (calculated on their average of the announced profits before taxes of the last three years, combined with their last year's assets (see SEV Membership Annual Subscription Fee Formula).
- Association – Sector/ Professional Association Membership** – pay a fixed annual subscription fee of € 2.000.
- For the New Members**, a 30% discount is offered for the first year.
(does not apply to minimum subscription fee rate of € 1.000)
(does not apply to Sector/Professional Associations rate of € 2.000)
- A one-time € 500 registration fee applies to Corporate Membership/Association/Sector Organization Membership
- For Legal Offices**
- € 2.000 for ≤ 20 employees
- € 5.000 for ≥ 20 employees

2. Corresponding Membership – Have No Voting Rights:

- Foreign Companies that have business transactions with Greece, but with business activities in foreign countries.** Companies pay a fixed annual subscription fee of € 10.000 regardless of the size of the Company.
- Companies of foreign countries, without legal representation in Greece, but with interest for the Greek economy and the Greek market.** Companies pay a fixed annual subscription fee according to size based on number of employees.
- For companies up to 100 employees **€ 2,000**
- For companies with over 100 employees **€ 4,000**
- Associations and Sector Organizations of foreign countries, without legal representation in Greece, but with interest for the Greek economy and the Greek market** – pay a fixed annual subscription fee of € 500 regardless of the size of the Association.
